ORDINANCE NO. <u>O 2019-007</u>

AN ORDINANCE OF THE TOWN OF DAVIE, FLORIDA, AMENDING SECTION 3.6 OF THE TOWN OF DAVIE POLICE PENSION PLAN TO PROVIDE FOR CONTINUED PAYMENT OF RETIREMENT BENEFITS FOR RETIREES WHO ARE REHIRED AS SCHOOL RESOURCES OFFICERS OR APPOINTMENT AS RESERVE POLICE OFFICERS; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Article VIII, Section 2 of the Florida Constitution and Chapter 166 of the Florida Statutes, the Town of Davie is authorized to protect the public health, safety, and welfare of its residents and has the power and authority to enact regulations for valid governmental purposes that are not inconsistent with general or special law; and

WHEREAS, the proposed ordinance creation is within the police power of the Town of Davie; and

WHEREAS, the Town Council deems it to be in the best interest of the citizens and residents of the Town of Davie to adopt the proposed ordinance; and

WHEREAS, the Town Council of the Town of Davie has previously adopted Ordinance 99-20 amending and restating the pension plan for sworn full-time Police Officers; and

WHEREAS, the Town Council has legally advertised its intent to amend section 3.6 (c) of the Town of Davie Police Pension Plan; and

WHEREAS, section 3.6 (c) of the Davie Police Pension Plan will now read as follows:

3.6 Reemployment.

(c) Reemployment of Retirees as School Resource Officers or appointment as Reserve Police Officers. Notwithstanding subsection 3.6(b), a member retired with a normal service retirement benefit who is rehired by the Town as a school resource officer or appointed as a reserve

member meets the requirements of the Internal Revenue Code and corresponding regulations of the Department of the Treasury for age, service, or a combination of age plus service. A rehired/appointed retired member_receiving an in-service distribution

under this paragraph shall not be classified as a full-time police officer and shall not be eligible to earn additional service in the Davie Police Pension Plan.

WHEREAS, the Town of Davie is interested in appointing retired members as Reserve Police Officers; and

WHEREAS, the Internal Revenue Code and IRS regulations govern "in service" distributions; and WHEREAS, the Town Council finds that this Ordinance is necessary for the preservation of the public health, safety and welfare of the Town's residents; and

WHEREAS, pursuant to the Internal Revenue Code and regulations, police officers must be at least 50 years old and retired to be eligible to be appointed as a Reserve Police Officers; and

WHEREAS, the Town Council has held two advertised public hearings in accordance with Florida Statutes; and

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

- Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Ordinance.
- Section 2. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict hereby repealed.
- Section 3. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion of this ordinance.

Section 4. This ordinance shall take effect immediately upon its passage and adoption.

Actuarial Impact Statement for Plan Amendment

Dear Dave:

We are pleased to enclose an Actuarial Impact Statement in support of the proposed amendment of the Town of Davie Police Pension Plan. The Actuarial Impact Statement is for the following changes to section 3.6(c) of the Davie Police Pension Plan:

(c) Reemployment of Retirees as School Resource Officers or appointment as Reserve Police

Notwithstanding subsection 3.6(b), a member retired with a normal service retirement benefit who is rehired by the Town solely as a school resource officer or appointed as a reserve police officer may receive an in-service distribution provided that the rehired/appointed retired member meets the requirements of the Internal Revenue Code and corresponding regulations of the Department of the Treasury for age, service, or a combination of age plus service. A rehired/appointed school resource officer retired member receiving an in-service distribution under this paragraph shall not be classified as a full time police officer and shall not be eligible to earn additional service in the Davie Police Pension Plan.

There would be no actuarial impact as a result of this change.
